Our Minister

What business are we in?

Let me ask you a question, “*What, as a church, have we not noticed lately?*” I know that this is an odd question - how can you notice what you haven’t yet noticed? Let me illustrate what I mean.

It is the year 1910. This is the age of the big transatlantic steamer. The seas were full of big, beautiful ships carrying the thousands of people to and fro across the Atlantic. The dominant companies in this business are Cunard and White Star. If you ask the people who ran Cunard and White Star what business they were in, they would have responded: “The transatlantic *shipping* business”.

Sadly, it was that kind of self-definition that sealed their demise. Locked into a worldview where the future was about bigger, faster ships, companies like Cunard and White Star were busy trying to create ships with bigger engines, more funnels, and iceberg-proof hulls. Yet, only a few years later a disruptive technology came along and sank the transatlantic shipping business and the White Stars and Cunards of the world. That piece of technology was, of course, the airplane.

If White Star and Cunard had seen their business from a different perspective, in other words not as a transatlantic shipping business but rather as a transatlantic *people moving business*, things might be very different today. Instead of flying in *Virgin* and *BA* and *Easy Jet* planes we might all be flying in Cunard and White Star planes.

How often as churches do we get the question: “*What do you do?*”

All too often we respond to questions like this with the ‘*what,*’ and forget to mention ‘*why*’ we do what we do. We invariably answer the question on autopilot and talk about parishes and worship services, social activities etc. In other words, we talk in terms of the logistics and the location of church buildings.

When Jesus was asked a similar question in Luke’s Gospel (ch15), instead of explaining what he was doing he told 3 stories that helped his listeners ‘see’ why he was doing what he was doing. From beginning to end everything Jesus did was *people focused* – not property or procedure focused. It is good to be able to explain ‘*what*’ we do but let’s never forget the ‘*why*’.

Why not take some time this week to read and reflect on how Jesus answered those who questioned him about his activities? Like its Saviour, the Church is called to be first and foremost a people-centred enterprise. If we forget to notice that we may, like Cunard and White Star, find ourselves replaced.

Linton Lifts

Margaret Torrance has sent an appeal for volunteers, below, and expresses a wish for responses within the next fortnight.



'I would like to take this opportunity to update you all on the 'slow but sure' progress being made towards the formation of a voluntary drivers scheme to take residents of West Linton and surrounding area, to and from health-related appointments.

As you will be aware, journeys by public transport are challenging when it comes to getting to the Borders General Hospital and other places patients of the West Linton Health Centre are referred to. It is particularly difficult for cancer patients needing to attend for treatment often several times in one week. The Red Cross did a grand job ferrying people back and forth, using volunteer drivers, but that organisation no longer runs the service, and Linton Lifts hopes to fill the gap.

However, as with most not-for-profit organisations, a Steering Group needs to be recruited before we can attract volunteer drivers. To that end, I am looking for the following:

Co-ordinator/s to deal with client bookings and communications with drivers, using designated email and mobile phone - these people need to be available during the day

A Treasurer to receive monies from clients, make payments to drivers, and manage funds - using electronic banking with the Bank of Scotland (once an account is set up) and manage insurance

A Secretary to arrange and minute meetings, and keep secure records

Committee members - two or three, to help with publicity, social media, press, trainings etc.

Volunteering can be very satisfying, and I would love to hear from anyone reading this who feels they may be able to help fill any of these roles, or indeed may know of someone who perhaps is looking to fill a gap in their lives following retirement or change of lifestyle.

*I know that some will be wondering about driving – rest assured, I will put the call out for more drivers when we have a steering group formed!
As for clients – there will be no shortage!*

Earth Hour 2024

Saturday 23rd March is the day we observe Earth Hour and you are warmly invited to take part in the following:

Litter Pick - Sat 23rd March 10-12 - coffee & cake in the Church. Bring protective gloves.

Earth Hour - Sat 23rd March 8.30 - 9.30 - candlelit music, verse and song. Bring a poem/song/music to share as we gather to support our planet.

‘Since its beginnings in 2007, Earth Hour has been known for the “lights off” moment, with individuals from around the globe switching off their lights to show symbolic support for the planet and to raise awareness of the environmental issues affecting it.

More than 15 years later, we are now at a tipping point with our climate and nature crises, putting at risk the fate of our one home and all our futures. We are on course to breach by 2030 the 1.5°C global temperature increase limit set by the Paris Climate Agreement, and nature - the source of our very livelihoods and one of our biggest allies against the climate crisis - is also under severe threat, facing alarming and unprecedented rates of loss globally.

The next 7 years are therefore crucial to all our futures - we have to stay under the 1.5°C climate threshold to avoid irreversible damage to our planet, and we need to reverse nature loss by 2030, ending the decade with more nature than we started, not less. To make this happen, individuals, communities, businesses, and governments must all urgently step up their efforts to protect and restore our one shared home.’

Medication blister packs: discard or recycle?

People have been discussing how to dispose of medication blister packs responsibly, seeking a practical recycling method.

This article explains the position and what we can do now.



How many blister packs are used domestically?

- *Over-the-counter medicines* Each person uses, on average, 70 paracetamol every year; say, six blister packs per person; UK wide, 400 million blister packs for paracetamol alone
- *Prescription medicines* In 2022, 1.10 billion prescriptions were issued in England alone; adding about 15% for rest of UK makes 1.26 billion; assume, say, four blister packs per prescription for 75% of these: 3.80 billion blister packs
- *Estimated total* 4.20 billion blister packs per annum (ie, 4,200,000,000!)

This is a rough, but conservative estimate. It excludes non-prescription medicines other than paracetamol, and all medicines used in NHS hospitals and health centres.

What happens to blister packs at present

Blister packs are made primarily from plastic and aluminium; these are recyclable, but the fusing of metal and plastic makes the process complex. The blister packs must be collected and taken to waste management facilities. The processes used there vary, but generally involve manual and mechanical means to break the blister packs down into their constituent metals, plastics and other materials; then bulk packing these materials and delivering them to manufacturers for use in recycled paper, metal and plastic products; a small residue goes to composting, incineration or landfill.

Currently, most local authorities don't accept blister packs in household recycling, so they are usually discarded in general domestic waste and go to landfill or incineration.

What might develop; and how you can help

Most waste management companies want bulk input and they charge for uplift. Individuals want free-to-use deposit or uplift of small quantities. The challenge is to bring these models closer

together.

Local authorities may be persuaded to change their policies if enough people lobby them with sufficient energy and persistence. *Pester your councillor!*

Recycling firm Terracycle and supermarket Aldi trialled a scheme for people to freepost blister packs directly to a recycling centre in suitably labelled envelopes. The project was too successful! The pilot funding ran out quickly, and the project is paused while they review options. It may be reinstated in amended form. *Monitor Aldi and Terracycle websites.*

What we can do now

Carlops Church supporters are keen to recycle, and a local waste management company has offered generous support. Bring your blister packs to the church and deposit them in the cardboard container situated prominently near the door. That container will be emptied regularly. The company will accept its contents free of charge and ensure that the blister packs are recycled professionally and according to good environmental practice.

We are grateful and thank the firm for its continuing support of Carlops Church and its endeavours.

The Column

The Edinburgh Courant – 21st July 1832

During a clear-out, we came across a copy of the “Edinburgh Courant” – 21 July 1832. Wondering why it had been kept, I started to read it, and this caught my eye!

Peebles-shire

RUTHERFOORD CASTLE to be LET, and entered in immediately.

It is half-way between Edinburgh and Biggar, on the new road by Linton and is fourteen miles from Edinburgh.

It contains nine rooms and kitchen, with scullery, milk-room, cellars, water closet, and other conveniences. There are lock-up coach houses and stabling for nine horses, and additional accommodation will be erected to suit a tenant.

The Dumfries coach runs to the house, and there is a great thoroughfare upon the road. It is a good situation for an active tenant, who may be accommodated with a farm.

The mansion house of Rutherford, within half a mile of the inn, may be let with it, or separately. It is favourably situated for being occupied as lodgings, on account of its vicinity to Edinburgh, and the celebrated mineral well of Heaven-aqua being upon the land, and which is more powerful and efficacious than the Tunbridge water.

Looking at our map of 1821, which only shows the old Roman road, the new road is our very own A702, and we still have the Dumfries “coach” stopping on request.

I’m not sure of the whereabouts of the mansion, but the heavenly aqua well can still be found, though I can’t vouch for its efficaciousness!

Still to work out why this particular paper was kept by one of our ancestors – maybe it was just lining a drawer?
